#### **Discussion Items**

#### **Madras Stakeholders Meeting**

There was discussion regarding the proposed Public Consultations for the new Madras College. The Education Consultation is running until 22 December, The planning Consultation will be announced in the near future. Fife Council intends to have two "Drop in Events" to collect comments from the public regarding the new school. One event will be in Tayport the other in St Andrews Town Hall. Fife Council hope the "drop in events" will cover both consultations. It is difficult to see how this can be achieved as the planning consultation will run for 12 weeks from date yet to be announced.

Some planning committee members believe it is essential the Community Council responds to the above mentioned consultations and that the time has come for the C C to confirm its position regarding the new school, they would like to see the C C produce a press release to that effect. Others believe that making such a statement at this stage could result in a difference of opinion within the CC that could have a detrimental effect on the running of the C C.

There is agreement in the planning committee that a single site Madras would be beneficial to the children of St Andrews. The difficulty arises in agreeing to site for a single school.

After more discussion it was agreed that another meeting was needed to discuss this subject further. The meeting will take place on 22 November in room 306 at Madras Kilrymont, it will be open to all C C members.
