- 6. Recent Applications As detailed in the Planning Applications 28th January to 11th February.
 - a. All noted as No Comment except:
 - b. ACTION HG: To object to the new Westburn Lane plans (13/00280) on the following grounds:
 - a. Balconies overlooking No 58 invasion of privacy.
 - b. Angle of roof too shallow not in keeping with conservation area.
 - c. Design too modern not in keeping with conservation area.
 - d. Should use Scottish slate for roofing.
 - e. Buildings are too high should be 2 storey rather than 3 storey.



- f. Amount of extra traffic on Westburn Lane too narrow for two way use with all the extra vehicles.
- c. **ACTION HG:** To object to 13/00291 on the positioning of the ventilation close to a neighbours garden cite 07 application that rejected plans on this issue.
- d. **ACTION HG:** To object to 13/00045 on the conversion of a retail outlet to an office space. Loss of retail.

7. Other Ongoing Items

- a. Feddinch Complaint to Scottish Ministers PU
 - i. Noted that the Reporter is likely to issue a rejection of the Appeal as further information from Applicant not forthcoming. PU recommends we wait for decision.
- b. McCarthy & Stone 18 Flats at St. Nicholas HG
 - i. HG noted that NEFAC continued the application for further information on Affordable Housing. Brian Thomson also indicated several councillors unhappy about design. HG will review and comment on Chris Smith recommendation before next NEFAC Meeting.
- c. Planning Appeal Kenly Green and Lingo Wind Farms PU
 - i. PU asked everyone to look at Fife Wide plan on positioning of Wind Farms. Recommended that the Planning Committee look at ways to object to the impact of several wind farms in close proximity.
 - ii. **ACTION PU:** To draft an objection to the combined massing of Kenly and Lingo on the centre of North East Fife.
- d. Planning Appeal 44 South Street HG
 - i. HG noted that the reporter site visit for this appeal has taken place, complete with inappropriate parking by Fife Council official.
- e. Planning Appeal Wonder Years Nursery PU
 - i. PU attended the Appeal Visit. Same reporter as for 44 South Street. Listened to all comments. Hopefully that appeal will be refused.

 - i. HG presented the proposed development areas in the Main Issues Report. Noted that all 3 areas in St. Andrews and 2 in Strathkiness are within St. Andrews Greenbelt.
